


STOWAGE OF THE BRITISH SLAVE SHIP BROOKES UNDER THE REGULATED SLAVE TRADE


Act of 1789.

Note: The Deck under the Regulation Act of 1789, was altered by carrying Slaves. She could stow this number by following the rule adopted in this plate, namely of allowing a space of 61" by 11" 4" to each man, 51" 6" by 11" 4" to each woman & 25" by 11" 4" to each boy, but so much space as this was taken allowed over after the Regulation Act it was given up the occasion of the Slave Merchant that before the above Act the Deck had at one time carried as many as 600 Slaves. This was done by taking some out of space of being there, and some of the technical laws that were given upon within the destined legs of the other.

PLAN SHewing THE STOWAGE OF 130 ADDITIONAL SLAVES ROUND THE WINGS OR SIDES OF THE LOWER DECK BY MEANS OF PLATFORMS OR SHELVES (IN THE MANNER OF GALLERIES IN A CHURCH) THE SLAVES STOWED ON THE SHELVES AND BELOW THEM HAVE ONLY A HEIGHT OF 2 FEET 7 INCHES BETWEEN THE BEAMS: AND FAR LESS UNDER THE BEAMS. 

amidships.





Fig 6.
